According to a previously reached agreement, the **Buyer** picks up purebred Devon Rex kitten dewormed, vaccinated, microchipped, and neutered. BUYER INITIAL \_\_\_\_\_

**Seller** provides originals of vaccination certificates, microchip information, castration certificate, and vet passport. CCA (Canadian Cat Association) registration will be provided when the kitten turns one year old at the **Buyer's** request, providing actual information about the **Buyer-Owner**. BUYER INITIAL \_\_\_\_\_

**The Seller** guarantees this Devon Rex is purebred and eligible for CCA registration. A veterinarian has seen this kitten and has a health record. It is **Buyer's** responsibility to have the kitten examined by a veterinarian within 72 (seventy-two) hours of taking possession at his/her sole expense. If this exam is not done, all health guarantees listed below are canceled for the protection of the **Buyer** as well as the **Seller**. If such a veterinarian certifies a life-threatening illness/defect in the health of the kitten that is proved by an examination and/or any blood test, the **Seller** must be notified immediately, and the kitten may be returned with a copy of the veterinarian report. In such case, upon receipt of the kitten and veterinary report of illness, the **Seller** will refund all money paid for the kitten. BUYER INITIAL \_\_\_\_\_

**Seller** shall not, under any circumstances, be responsible for covering any medical expenses incurred by the **Buyer** for the kitten while it is in their possession. Additionally, **Seller** will not be liable for any other costs, such as transportation or shipping. BUYER INITIAL \_\_\_\_\_

**Seller** makes no representations or guarantees whatsoever as to the physical features, attributes, personality, or temperament of said kitten. BUYER INITIAL\_\_\_\_\_

If the kitten is ever found to be malnourished, abused, or neglected, the **Buyer** must immediately return it to the **Seller** without any refund of the purchase price. BUYER INITIAL\_\_\_\_\_

After leaving the cattery, the **Buyer** is responsible for the kitten`s physical health which means that the **Buyer** takes all responsibilities for making other vaccinations needed annually. Vaccinating against FeLV (Feline Leukemia) and FIP (Infectious Peritonitis), or vaccinating with live vaccines are not recommended. If the **Buyer** and his Veterinarian decide to give either of these vaccines, the **Seller** shall not be held responsible in any way. No refund or replacement will be given.  
BUYER INITIAL\_\_\_\_\_

The **Buyer** is informed and responsible for activating **FREE 4 weeks** (four weeks) Health insurance with TRUPANION, within 24 hours, provided by the cattery. BUYER INITIAL\_\_\_\_\_

The **Buyer** is informed and responsible for re-registering the kitten`s microchip under his/her name.  
BUYER INITIAL\_\_\_\_\_

The **Buyer** agrees to give the kitten the best possible care. The **Buyer** will at no time allow the kitten to go outside unattended. The **Buyer** agrees not to declaw the cat/kitten for preventive purposes. Declawing is permitted with laser surgery for valid kitten`s medical reasons. All guarantees/replacements are canceled once declawing is done by the **Buyer**.  
BUYER INITIAL\_\_\_\_\_

This kitten is guaranteed for the first year against a GENETIC problem so severe that it prevents the animal from living a normal life as a pet, i.e.HCM. Upon receiving written proof of a diagnosis of HCM by a certified Veterinary Cardiologist, or diagnosis of other severe genetic health conditions by a certified veterinarian. A veterinary autopsy/necropsy report must be provided at the **Buyer's** expense to verify the cause of death. The **Seller** will replace the kitten with another kitten of similar quality when available. If the **Buyer** does not want a replacement kitten, the **Seller** will have no further obligation towards the **Buyer**. BUYER INITIAL\_\_\_\_\_

This contract does not cover any other treatable illness that kittens may commonly get, such as, but not limited to eye infections, respiratory infections, ear infections, parasites, or fungal infections, although **Seller** does the best to limit such occurrences. This contract does not cover any illness, treatable or otherwise, that said kitten may contract later in life, or after the warranty date. No other illness/injury is covered under this warranty. There is no guarantee concerning any imperfect feature, such as crooked teeth or nose, kinked tail, or head bump. These are factors that the **Seller** cannot always predict or control, and therefore will not guarantee. The following are covered illnesses: FELV, FIV, PKD, and serious high-grade heart murmur of grade 3 or higher. BUYER INITIAL\_\_\_\_\_

The **Buyer** must understand that the kitten may require additional boosters to achieve immunity, as well as annual vaccinations. The **Buyer** must understand that vaccinations do not guarantee immunity. The **Buyer** promises to maintain a preventative vaccination schedule as necessary and to keep the cat in good health. BUYER INITIAL\_\_\_\_\_

The **Buyer** will not give, lease, loan, or sell the cat/kitten to another person, institution, animal shelter, cattery, or any similar entity without **Seller's** written approval. If the kitten is transferred to another person, the new owner (s) must agree to abide by these terms. BUYER INITIAL\_\_\_\_\_

**The Seller** strongly advises against keeping cats or kittens with dogs that have any history of aggression. **Seller** does not warranty any injury or death to a kitten resulting from a dog attack or a dog being rough with a kitten. **The Seller** also advises against leaving kittens alone with very young or rough children who may accidentally injure a kitten. **The Seller** does not warranty any injury whatsoever that occurs once the kitten has left home. The **Buyer** will ensure that an adult is responsible for the care of this kitten. The **Buyer** will not leave this kitten unsupervised with a child or animal that might harm it. BUYER INITIAL\_\_\_\_\_

Please note that during times of stress, such as going to a new home, kittens can exhibit temporary signs that may include: sneezing, runny nose, watery eyes, diarrhea, and/or constipation. To help reduce the signs of stress feed the cat the identical food that the **Seller** was feeding, and offer bottled water, as well as taking reasonable measures to reduce stress. You can do this by slowly introducing them to the house and the members of the household, as well as limiting the time they are with strangers, toddlers, and other animals. Take the time to socialize your kitten and shorten the period of adaptation. It is strongly recommended not to use litter staff aromas as they can cause breathing problems and lung disease. Any disputes arising from the purchase of this kitten shall not be shared on social media or any online platforms by the **Buyer, Seller,** or their associates. A violation of this clause will result in a \$5,000 penalty. BUYER INITIAL\_\_\_\_\_

Before leaving the cattery the kitten is fed dry food **PURINA PROPLAN UNDER ONE YEAR** raw mixes: beef meat, pork hearts, chicken necks. The **Buyer** understands that changing food can cause temporary diarrhea. The **Seller** recommends keeping the same dry food while slowly transferring it to another type of dry food. The **Buyer** got full information about food and litter preferences. BUYER INITIAL\_\_\_\_\_

**Devon Rex are very sociable cats who enjoy being with humans and will suffer from a lack of attention. Please take the time to play, talk, and love your *Devon Rex*.**

*The more love and attention you give them, the more you will get in return.*
